The United Teachers of Monroe, UTM is hereby designated as my agent to represent me in collective bargaining with the Monroe County School Board and in negotiations with all other levels of authority which deal in school matters. I also request and authorize the Monroe County School Board to deduct from my earnings and transmit to the organization an amount sufficient to provide for regular payment of the membership dues as certified by the organization. The number of such deductions shall be agreed upon by the United Teachers of Monroe and the school administration officials. I understand that such deduction is revocable upon thirty (30) days written notice to the employer and employee organization provided, however, that such deduction shall be in force during the time of the collective bargaining agreement. Dues paid UTM may not be deductible for Federal Income Tax purposes: However, under limited circumstances, dues may qualify as a business expense. I hereby waive any right and claim to said monies so deducted and transmitted with this authorization and relieve the Board and all of its officers of any liability.
